

This Privacy Policy discloses the privacy practices for Affiliate Junction.

Your privacy is critically important to us. At Affiliate Junction we have a few fundamental principles:-

- We don't ask you for personal information unless we truly need it. (We can't stand services that ask you for things like your gender or income level for no apparent reason)
- We generally don't share your personal information with anyone except to comply with the law, develop our products, or protect our rights.
- We don't store personal information on our servers unless required for the on-going operation of one of our services.

The following explains what information we collect from you (the "User" or the "End User") and how we use that information;

What data we collect and why?

Our vision is to maximise the rewards for all affiliates of Affiliate Junction and to provide as many benefits as possible. The key way in which Affiliate Junction provides value is to share with members the commissions we receive from our affiliated stores. The information we collect (name, business registration information, email address, and IC number) is used to track and accurately transfer the commission affiliates earned to their account.

Additionally, we may use information on the stores you visit or the offers you view on the Site to select special offers that will be relevant to you. Except at an aggregate level, however, we do not share that information with our store partners or other third parties.

Finally, Affiliate Junction collects data on the devices that access or attempt to access our Site. This device data is used in conjunction with a third party security partner to identify and prevent fraudulent activity and does not include personally identifiable information.

Who sees your personal information?

We will share your personal information with third parties only in the ways that are described in this Privacy Policy. We do not sell your personal information to third parties.

Only a very limited number of our employees ever have access to your personal information. We may use third-party contractors or vendors to help us provide some of our services. If we need to disclose personal information for them to provide the services, it is with the requirement that the information will be kept confidential and used only to provide those services. In addition, our affiliates, subsidiaries, service providers, and other entities may collect personal information about your browsing habits over time and across different websites when you use our Site.

We reserve the right to disclose your personal information as required by law and when we believe that disclosure is necessary to protect our rights and/or to comply with a judicial proceeding, court order, or legal process served on us or to protect us and our members from losses.

While browsers allow you to disable the usage of cookies, we do not change our practices in response to a "Do Not Track" signal in the http header from your browser or mobile application.

If we (or one of our affiliated companies) are involved in a merger, acquisition, or sale of all or a portion of our assets, you will be notified via email and / or a prominent notice this website of any change in ownership or uses of your personal information, as well as any choices you may have regarding your personal information.

How we keep your information secure?

The security of your personal information is important to Affiliate Junction. The Site uses a secure, encrypted connection (called an SSL connection) on all pages where you access or transmit personal information.

Your privacy with Affiliate Junction

Affiliate Junction will never ask for your username, password or any other personal information in an unsolicited phone call, email or letter. Furthermore, any contact with Affiliate Junction customer service in which personal information is exchanged with a customer service representative will be used only for the purpose of satisfying your request. Any personal information you provide will not be recorded or used for any reason beyond that of the stated request.

We reserve the right to modify this privacy statement at any time, with or without notice, so please review it regularly.

Your privacy with our stores and advertisers

Affiliate Junction does not record personal information passed from our affiliates to affiliated stores. Order information, including order numbers and amounts, may be available to Affiliate Junction, the store, or third party affiliate program management companies for accurate tracking purposes, but these information will not be released by Affiliate Junction to other parties.

Affiliate Junction contains links to various other sites. Each of these sites has a privacy policy that may differ from that of Affiliate Junction. If you wish to receive special offers directly from a store, neither this privacy policy nor our opt-out policy applies to those communications. Instead, please refer to the relevant store's privacy policy and opt-out policy.

Our policies on email

Affiliate Junction sends two types of email to members: customer service emails required to maintain the Affiliate Junction program (like commissions earned); and promotional emails that feature exceptional offers and advertisers. You may choose not to receive promotional emails at any time by clicking the "unsubscribe" link in an email.

Affiliate Junction does not support spamming and we explicitly prohibit it in our Terms of Service. If you would like to report an incident of spamming, please contact us. We will investigate and take suitable action.

Cookies and how are they used

Cookies are small text files that a web site can write to your computer. We may use cookies to identify you and allow you to log in once to Affiliate Junction and shop without having to log in again. Cookies are also used by many of our merchants to identify you as a Affiliate Junction member.

Affiliate Junction requires its members to have cookies enabled in order to track transactions on the Site to accumulate commissions.

Your choices and responsibilities

We may send you emails periodically on new features or special offers. On every one of these emails you will be given the choice to unsubscribe from Affiliate Junction's promotional mailings. Simply follow the directions in any of our emails if

you wish to unsubscribe.

It is the affiliate's responsibility to update and maintain accurate contact information in their account. You can make changes by visiting your account page and update your information. Email and street addresses that are entered into a member's personal profile page are the addresses that will be used for all contact. Affiliate Junction is not responsible for any loss that may arise as a result of an incorrect address provided by you.

We will post all changes to this Privacy Policy here at our site. You are responsible for checking periodically on policy updates.
