

## Welcome to Affiliate Junction!

We are I Synergy (M) Sdn Bhd (Company No: 1062594-W) trading as [www.aj.my](http://www.aj.my) ("Affiliate Junction"). By using our Site or any of Affiliate Junction Services, you are subject to the following Terms of Service ("TOS") as well as our Privacy Policy published on our Site. The term 'you' refers to person accessing or using the Site or our services, or the organisation or company on whose behalf of that person accesses the Site or our Services. This TOS constitutes the entire agreement between you and Affiliate Junction.

Affiliate Junction is an affiliate network and platform for businesses to register themselves as affiliates through submission of business registration documents, Malaysian identity card number and other important supporting documents. Upon successful registration, businesses become affiliates to various advertisers found on our Affiliate Junction platform and may earn commissions, revenue and other profits through promotional activities and successful transactions. Affiliate Junction does not sell or rent your personal information to third parties, and Affiliate Junction does not 'spam' its members. Affiliate Junction does not install or require you to install software on your computer.

### Becoming an Affiliate

By registering as an affiliate ("Affiliate") in Affiliate Junction's program ("Program"), or by utilising any of the Program's applications ("Applications") or services ("Services"), you agree to be bound by this TOS. You must have a valid business registration name and license and a Malaysian identity card number to register as an affiliate in the Program. Affiliate Junction can inform when commission or other earnings are transferred to your account via the email address that you provide. Affiliates should provide accurate information when registering as an Affiliate and is solely responsible for the User ID and activity(ies) that occurs while signed in to or while using Affiliate Junction Applications or Services using the User ID. Members must be at least 18 years of age or older and have a registered business entity. The opportunity to earn commissions are offered at the sole discretion of the Program, and the Program has the right to change this TOS in whole or in part, at any time, with or without notice.

*All newly registered member who register online is deemed to have agreed with the Program's standard operating procedure in which the registered member will be assigned an affiliate by our system as the referrer.*

## Earning Commissions

Earning a commission through promotional activities is straightforward.

When promoting an advertiser's products or service, Affiliate Junction's platform provides trackable data and information to ensure Affiliates are rewarded with commissions for successful transactions. Each commission amount is dependent on the participating advertiser, merchant or their products and services. Commissions are earned and paid out on a monthly basis once verified as successful.

Please note that the net transaction amounts may exclude taxes, fees, shipping, gift-wrapping, discounts or credits, returns or cancellations, and extended warranties. Certain Affiliate Store exclude a limited number of products and purchases from the Program.

Affiliate Junction does its best to minimise and maintain an up-to-date list of exclusions on our Site. Please note that to earn commissions into your bank account, you must earn a minimum threshold of one hundred Ringgit Malaysia (RM100). Once you earn the threshold amount, commissions will be banked in no later than the 20<sup>th</sup> of the following month. If you believe you are entitled to a commission which may not have been tracked, you may provide proof of the transaction and Affiliate Junction will use its discretion on whether to pay you the entitled amount.

## Updating & Maintaining Your Account

You must be logged into Affiliate Junction and enter your password to change your account information and preferences. You may check your account status and recent earning history at any time via the Affiliate Junction dashboard. For security purposes, it is recommended that you memorise your password and not write it down. You are responsible for keeping your password and other account information confidential. By using our Services, you represent that you will be responsible for maintaining your account and password and for restricting access to your computer. You also agree to be responsible for all activities that occur under your password and your account. Affiliate Junction will not be responsible for any loss or damage arising from your failure to comply with your responsibilities and obligations under these TOS. Affiliate Junction is entitled to act on instructions received under your password and is not responsible for any credits or debits made to your account by someone else who uses your password. By entering any information on this Site, you represent and warrant that;

- you are at least 18 years of age;
- you are a registered entity;

- you are using your actual identity;
- you have provided only true, accurate, current and complete information; and
- you will maintain and promptly update the information that you provide to keep it true, accurate, current and complete.

### Receiving Communications from Affiliate Junction

By signing up for a membership, you agree to receive communications that are related to your account & membership as well as periodic affiliate-related email that highlights latest news, events and promotions. You can opt-out of receiving emails that are not account related by clicking on the unsubscribe link on any of the emails. Since we need to communicate account information with you in order to operate our service, you cannot unsubscribe from account information emails. Rest assured, that we do not send emails unnecessarily to our Affiliates. If you do not wish to ever hear from Affiliate Junction again, even if it is just to know that we have awarded you commission, you can close your account by notifying our customer service department through an email to [contact@aj.my](mailto:contact@aj.my).

### Refunds

Newly registered Affiliates may request for refunds for their registrations should they wish to terminate their accounts within 10 calendar days of their registration. Termination during that period will entitle Affiliates a full refund to their bank accounts without requiring further reasons or supporting documents.

During purchase of products and services provided by any Affiliate Junction Program or Service, affiliates may request refunds within 30 days of the product or service being provided if the affiliate can provide proof that said product or service has not been used, consumed, been damaged or lost.

### Protecting Your Information

Affiliate Junction does not sell or rent your information to third parties. Affiliate Junction requires your name, business information and IC number in order to accurately track and transfer commissions and other rewards earned through Affiliate Junction to your account. Any other information gathered by Affiliate Junction will be used only to improve your experience, for example by minimising the irrelevant content or offers and increasing the offers you see from your favourite advertisers. As detailed in Affiliate Junction's Privacy Policy, Affiliate Junction does not disclose your information to third parties except as necessary;

- for Affiliate Junction's agents and service providers to make Affiliate Junction's payments to you;
- to comply with government agency or court orders or requests;
- in providing aggregated or non-personalised marketing services for advertising or store partners; or
- for Affiliate Junction's agents and service providers to send Affiliate Junction communications to you.

### Inactive Affiliate Accounts & Deactivation of Account

If your account is inactive for more than six (6) consecutive months, we reserve the right to delete your account. As an Affiliate, you are subject to an expiry date that follows the purchased Affiliate package, which entitles you access to Affiliate Junction and its Program or Services. You must participate and maintain specific activities as an Affiliate in order to extend your account's active status. If your account is inactive, suspended or terminated, you will not be entitled to all of the commissions that you have accumulated unless your account status is returned to active.

### Intellectual Property

Affiliate Junction and all its contents are copyrighted materials, protected by Malaysian and international copyright laws. The compilation of content on our Site is the exclusive property of Affiliate Junction and may not be used for any other purpose other than those set forth on the Site. The services and information provided herein are solely for your own private use. You are only permitted to use the Affiliate Junction Applications and Services as expressly authorised. Nothing contained herein transfers any express or implied right, title or interest in this Site to you. As between you and us, you retain any intellectual property rights in any copyrighted materials and trademarks that are contained in Content that you post to the Site. You grant us an irrevocable, perpetual, non-exclusive, royalty-free, fully paid, worldwide license, with rights to sublicense through multiple levels of sublicensees, to reproduce, make derivative works of, translate, distribute, publicly perform and publicly display in any form or medium, whether now known or later developed, make, use, sell, import, offer for sale, otherwise commercially exploit and exercise any and all such rights, under any and all of your intellectual property rights related to the Content in any manner we choose. ### Governing Law And Dispute Resolution

The Site is controlled by Affiliate Junction from Kuala Lumpur, Malaysia. This Agreement, your use of the Services, and all related matters are governed solely by Malaysian laws, excluding any rules of private international law or the conflict of laws that would lead to the application of any other laws. Any controversy or claim arising out of or relating to this Agreement, or the breach thereof, shall be settled by arbitration administered by the Asian International Arbitration Centre (the "AIAC"), in accordance with the procedures of the AIAC Rules of Arbitration, and judgment on the award rendered by the arbitrator may be entered in any court having jurisdiction thereof. The arbitration will be before a single arbitrator. The place of arbitration will be Kuala Lumpur, Malaysia. Notwithstanding the foregoing, you or Affiliate Junction may seek injunctive relief from an appropriate court located in Kuala Lumpur, Malaysia prior to or during the arbitration. Any claim or cause of action you may have arising from, connected with, or relating to your use of the Site, this TOS, or any related matters must be commenced within six (6) months after the claim or cause of action arises, after which time the claim or cause of action is forever barred, regardless of any statute or law to the contrary.

#### Program Limitations, Qualifications & Disclaimers

Membership in Affiliate Junction is subject to this TOS.

Membership in Affiliate Junction is limited to individuals who are 18 years of age or older, with registered business entities. Affiliates may not use scripts or disguised redirects to derive financial benefit from Affiliate Junction. Affiliates must have Internet access and maintain a valid email address to be eligible to receive the privileges and benefits of membership.

Any failure to comply with the Affiliate Junction Agreement and this TOS, any fraud or abuse relating to the accrual or receipt of commissions and rewards, or any misrepresentation of any information furnished to Affiliate Junction or its affiliates by you or anyone acting on your behalf may result in the termination of your membership and forfeiture of your accrued commissions and any rewards.

It is your responsibility to check your account regularly to ensure that commissions have been properly credited and that your account balance is accurate. If you do not believe that commissions has been correctly credited to your account you must contact our Customer Service at [contact@aj.my](mailto:contact@aj.my) within ninety (90) days of the transaction. Should you disagree with any adjustments made to your account or payments made to you, your sole remedy is to withdraw from the Affiliate Junction.
